The purpose of this modification is to:

- (1) to revise Paragraph B.4 - Consideration and Obligation, Subparagraph (b), to provide incremental funding in the amount of \$200,000.00 thereby increasing the obligated amount of the subject contract from \$2,195,443.40 to \$2,395,443.40; and
- (2) incorporate Paragraph H.25 - Release of Information -- Construction Related Documents under Section H - Special Contract Requirements.

Accordingly, the following changes are hereby made:

1. Under Section B - Supplies or Services and Price/Costs, Paragraph B.4 - Consideration and Obligation, Subparagraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

**"B.4 CONSIDERATION AND OBLIGATION**

- (b) The amount currently obligated by the Government with respect to this contract is \$2,395,443.40 of which the sum of ~~\$188,679.24~~ <sup>42,264,746.41</sup> represents the reimbursable costs and of which ~~\$14,320.76~~ <sup>133,696.99</sup> represents the fixed fee." <sup>2/12/13</sup>

2. Under Section H - Special Contract Requirements, Paragraph H.25 - Release of Information -- Construction Related Documents, is hereby incorporated under the subject contract as follows:

**"H.25 RELEASE OF INFORMATION -- CONSTRUCTION RELATED DOCUMENTS**

Construction related documents, to include floor plans which are hereby attached to this modification and made a part hereof this contract, are considered sensitive information and shall be protected by the Contractor accordingly (i.e., steel constructed safes with combination locks or padlock protected steel filing cabinets). No copies of these documents shall be made or distributed by the Contractor beyond those needs associated with this specific contract. At the conclusion of this effort, as well as any requests of the NRC Project Officer, the Contractor shall return these floor plans and a copy of any revisions thereto, inclusive of all associated copies, in an AutoCad 2000 format, to the U.S. Nuclear Regulatory Commission; Division of Facilities and Security; ATTN: William K. Harris; Mail Stop: T-7-D24; Washington, D.C. 20555."
