The purpose of this modification is to provide incremental funds in the amount of \$16,000.00, thereby increasing the obligated amount from \$231,500 to \$247,500. The contract is therefore modified as follows:

Under Section C.3, Consideration and Obligation—Delivery Orders (JUN 1988), the first sentence of paragraph (b) is deleted in its entirety and replaced with the following:

"(b) The amount presently obligated with respect to this contract is \$247,500."
