The purpose of this modification is to: (1) confirm verbal authorization given on May 23, 2003 to continue to provide software maintenance and support for FileNET Document Management Software; (2) exercise eight, 1-month option periods under Option Year 1, commencing in April 1, 2003 and expiring November 30, 2003; and (3) provide funding in the amount of \$358,948.40 to cover the cost for the option periods, thereby increasing the firm fixed price amount of the contract. Accordingly, the contract is modified as follows:

Under Section B.4, "CONSIDERATION AND OBLIGATION-FIRM FIXED PRICE (JUN 1988)," the firm fixed price amount of the contract is increased by \$358,948.40 from \$1,166,582.30 to \$1,525,530.70. Therefore, the sentence under this section is deleted in its entirety and replaced with the following in lieu thereof:

"The firm fixed price of this contract is \$1,525,530.70."

Under Section B.5, "DURATION OF CONTRACT PERIOD," as a result of exercising eight, 1-month option periods, the expiration date of this contract is extended until November 30, 2003. Therefore, the sentence under this section is deleted in its entirety and replaced with the following in lieu thereof:

"This contract shall commence on February 1, 2001 and will expire on November 30, 2003. The term of this contract may be extended at the option of the Government, for two additional, 1 month periods and two additional 1-year periods, by written modification to the contract."

A summary of obligations for this contract, from award date through the date of this action, is given below:

Total FY03 Obligations:	\$448,685.50
Cumulative Total of NRC Obligations:	\$1,525,530.70

This modification obligates FY03 funds in the amount of \$358,948.40.

All other terms and conditions of this contract remain unchanged.
