SUBJECT: REVISED MINUTES OF THE COMMITTEE TO REVIEW GENERIC  
REQUIREMENTS MEETING NUMBER 385

The Committee to Review Generic Requirements (CRGR) held special Meeting No. 385 on May 20, 2003, from 2:00 P.M. to 4:00 P.M., with the attendees listed in Attachment 1. The purpose of this meeting was to review a proposed Bulletin, "Potential Defective 1-inch Valves for UF<sub>6</sub> Cylinders," ADAMS Accession No. ML031560119. The slide presentation is located in ADAMS, Accession No. ML031550574.

Ms. Adelaide Giantelli and Mr. William Troskoski briefed the CRGR on the proposed Bulletin, "Potential Defective 1-inch Valves for UF<sub>6</sub> Cylinders."

Following discussion of the proposed package, the CRGR recommended and the staff agreed to incorporate various changes in the body of the bulletin. The following lists delineates these recommendations:

- 1) The discussion section in the bulletin needs to be strengthened to support the need for a Bulletin. There should be text describing what is the urgency and what is the safety concern.
- 2) Under the "Requested Information" section, review the order and logic of the information request. It is considered by the CRGR, that the logic flow of paragraph "(B)" to paragraph "(A)" is more congruent than it is presently written.
- 3) Provide a clearer scope for the valve population in question. Indicate which valves are to be considered, those within the warehouse and/or those that are in service. Also, staff should consider the need to indicate what is an acceptable evaluation method for the different populations of valves.
- 4) Clarify who has ownership and responsibility for responding with the requested information as outlined by the Bulletin.
- 5) Indicate if there will be Temporary Instructions issued and what is the plan for any ensuing inspections.

The CRGR and staff agreed that the bulletin was not a backfit on the basis that it is a request for information. Furthermore, the CRGR and the staff agreed that a review of the revised documents would be conducted via E-mail to verify if the accomplished modifications have adequately addressed the CRGR concerns or if another CRGR meeting would be necessary.

Subsequent to the CRGR review, the staff provided e-mail communications and a revised version of the Bulletin which adequately addressed all of the CRGR concerns. The communications addressing the revisions can be located in ADAMS Accession No. ML031900457.
