Dear Ms. Morris:

We have received your request dated February 14, 2003, for a change to company ownership and relocation, with respect to registration NR-1128-D-101-E, for the Model Nos. Q200 Leakmeter and Leakmeter 120. In order to proceed with this action, we need the following information:

- A. Delineate the facility's name and location where the products are manufactured;
- B. Specify the serial number of the last unit that was distributed by ITI Qualitek, Inc. prior to March 1, 2003, and the number of completed units that were transferred to be distributed by Uson LP, and by Roper Industries;
- C. Change of ownership information discussing transfer of assets, products, records custody, contractual arrangements, and servicing arrangements for products previously distributed;
- D. Provide a new label for the devices indicating the new company name and the effective date of the label change;
- E. Confirm that no changes were made to the product since its initial registration or last amendment;
- F. Verify that there are no changes to previous commitments that have been made from a previous sealed source and device review for the continued service, repair and calibration of the Model No. 120 Leakmeter as stated in a letter from you to Anthony Kirkwood of the NRC dated March 21, 2001; and
- G. Provide details regarding the quality assurance program at the new location.
