SUBJECT: COMMUNICATIONS OF SUBSTANCE WITH BWIP

The following procedures for communicating with DOE/RHO are in effect:

1. Telecommunications of substance. Notify the designated DOE contact in your field at same time or earlier than the RHO contact in that field.
- 2a. Written communications of substance. NRC copy needed by RHO should be either sent to DOE PM with a request to transmit it to the RHO person, or (preferably) send duplicate copy simultaneously to DOE/RHO.
- b. NRC requests for information from DOE are to be made through NRC PM (R. Wright), except for items on the public accession list or that are in the public domain. Requests for such documents can be made directly to the source.
