DIFFUSION PLANTS

Attached for your use, effective immediately, is the NMSS Policy and Procedures Letter (P&PL) 1-59 which guides staff in the preparation of the "Report to Congress" on the health, safety, and environmental conditions at the Gaseous Diffusion Plants (GDPs). To reflect the lessons learned during the last review cycle, this P&PL is being updated.

The requirements to produce a "Report to Congress" are contained within Section 1701(b)(1) of the Atomic Energy Act of 1954, as amended, (AEA). This part of the AEA guides the U.S. Nuclear Regulatory Commission (NRC) on the recertification of the GDPs, and in addition, it requires that NRC prepare a "Report to Congress" on the health, safety, and environmental conditions at the GDPs. The "Report to Congress" must be submitted no later than the date that NRC issues the Certificate of Compliance for the GDPs. The staff preparation of the Report To Congress, last issued in 1999, is guided by P&PL 1-59.
