The purpose of this letter is to inform you of the designees I have identified for implementing Appendix 2 and Item (2) of Appendix 7 of the "Agreement Between the U. S. Department of Energy Office of Civilian Radioactive Waste Management and the Nuclear Regulatory Commission Division of High-Level Waste Management During Site Characterization Program and Prior to the Submittal of an Application for Authorization to Construct a Repository." In Appendix 2, paragraph 2 it states, "Controlled copies of all applicable YMPO Samples Acquisition and Handling Procedures will be provided to the NRC's Director, Repository Licensing and Quality Assurance Project Directorate, Division of High-Level Waste Management or designee."
