Scarbrough) held a telephone conference with representatives of the licensee, Duke Power, (N. T. Simms, E. Hyland, S. Karriker, T. Welch and J. Peele). The NRC Resident Inspector, J. B. Brady, was also in attendance with the licensee's staff.

The NRC staff indicated that it had reviewed the licensee's written request and found that the licensee had adequately explained the unexpected circumstances surrounding the request and had justified why the licensee could not submit the proposed alternative to the NRC early enough for the NRC staff to process it using normal relief request review processes. The NRC staff indicated that it had completed its review and determined that the proposed alternative is technically justified. Accordingly, the NRC staff provided a verbal authorization of the proposed licensee's alternative.
