NEVADA NUCLEAR WASTE STORAGE INVESTIGATIONS (NNWSI) PROJECT WEEKLY HIGHLIGHTS FOR THE WEEK ENDING JANUARY 8, 1988

- I. Critical Items Status
  - A. Site Characterization Plan

Production of the Site Characterization Plan Consultation Draft (SCP/CD) was completed this week with the printing of 500 copies of the document.

The SCP/CD was distributed by the printer. Distribution was arranged so that copies of the document arrived at the various destinations specified by Department of Energy/Headquarters (DOE/HQ) by the scheduled release date of January 8, 1988.

The three sets of references cited in the SCP were shipped on Tuesday, January 5, 1988, from Las Vegas. Reference sets were shipped to John Linehan, NRC; Robert Loux, State of Nevada; and the DOE/NV library.

B. Core Sample Management

## II. Significant Accomplishments/Information Items

Although field activities have resumed at the Nevada Test Site following the resolution of recent labor union disputes, prototype testing in the G-Tunnel is still on hold. Decisions on initiating the prototype testing program will be made as the fiscal year 1988 budget and pending legislation are clarified.

Sandia National Laboratories (SNL) transmitted Version 03.001 of the NNWSI Project Reference Information Base (RIB) to the Waste Management Project Office (WMPO) for publication. This satisfies Milestone M763.

A draft Action Plan for the consultation draft workshops to be held between the project, DOE/HQ, and the state was presented to the Technical Project Officer meeting in Las Vegas on January 5, 1988. This Action Plan included preliminary staffing requirements and schedule information.
