NEVADA NUCLEAR WASTE STORAGE INVESTIGATIONS (NNWSI) PROJECT WEEKLY HIGHLIGHTS FOR THE WEEK ENDING APRIL 22, 1988

I. Critical Items Status

A. Site Characterization Plan (SCP)

The Integration Group (IG) continued the Phase 1 roll-up process on the Site Activity Assessment Sheets submitted by Working Groups (WGs) 1-4 for site characterization activities.

The co-chairpersons for WGs 1-4 completed draft schedule/logic diagrams for those sections of the SCP Consultation Draft for which they are responsible. These diagrams are the basis for the Phase 2 Schedule analyses. The Phase 2 kick-off and briefing for WG 1-4 members was held in Las Vegas on Tuesday. The WGs then met individually to revise the schedule/logic diagrams and begin completing the Criteria for Cost/Schedule Analyses forms.

WGs 5 and 6 continued the Phase 1 Activity assessments for the Performance and Design Activities. These activities should be completed next week and Phase 2 work initiated.

Work continued this week on providing a complete set of SCP references to the U.S. Department of Energy/Headquarters (DOE/HQ).

B. Core Sample Management

Sample Management Facilities (SMF) staff continued to work with U.S. Geological Survey (USGS) Core Library staff to inventory core and records for transfer to the SMF. Ten UE25 boreholes have been completed. Consisting of a total of 17 boxes of cuttings, 137 core samples sealed in PVC pipe, 42 boxes of core, 13 waxed and 5 leach samples.

II. Significant Accomplishments/Information Items

Representatives from Sandia National Laboratories (SNL) and the Waste Management Project Office (WMPO) met with staff from the Hanford Engineering Development Laboratory (HEDL) on Monday to discuss the capabilities of HEDL in the repository design area.

SNL submitted a revised copy of the "SNL NNWSI Project Controlled Document System Procedures" to WMPO for approval, satisfying requirements of Milestone P989.

An informal meeting of the Project Seismic Design Cost/Benefit Analysis Working Group was held in Las Vegas on Friday.

A summary of the topics covered at the April 13 Exploratory Shaft Test Plan meeting was made available this week. The items covered were (1) the status of ongoing prototype tests being conducted in G-tunnel; (2) preliminary results of the Los Alamos National Laboratory (Los Alamos) dry-coring test that indicate advance rates of at least 18 ft/day and 97% core recovery; and (3) SNL activities that are presently ongoing or are planned in G-tunnel for the remainder of FY 1988, but are not part of the prototype testing program.

A meeting was held on Wednesday and Thursday with WMPO and the project participants to review and develop the material to be used in a presentation to DOE/HQ on the budget submittal for the FY 1990 Work Authorization System (WAS). The presentation is planned for April 26-27 in Las Vegas and will include representatives from all the project participants, as well as WMPO and DOE/HQ personnel.

Stephen Leedom escorted 45 members of the Nevada Nuclear Waste Study Group on a visit to the Nevada Test Site (NTS) on April 20.

One hundred-thirty copies of the second printing of the SCP have been distributed.

The Technical Data Advisory Group, with Don Livingston as chairman, met April 19. As a result of the meeting, draft procedures for the Reference Information Base and the System Engineering Property Data Base and the Technical Data and Information Management Plans are available and are being informally reviewed.
