SUBJECT: TSTF-447, TSTF-429, and TSTF-450 for NRC Review

Dear Dr. Beckner:

EXCEL Services Corporation is making this submittal on behalf of the Technical Specification Task Force (TSTF).

Attachment A contains the NRC verbally requested revised pages for TSTF-447, Revision 1, "Elimination of Hydrogen Recombiners and Change to Hydrogen and Oxygen Monitors," to correct minor editorial issues. The following corrections are made to Revision 1:

- NUREG-1432, Page B 3.6.13-4 - Added a revised Specification number in the upper right corner.
- NUREG-1434, Pages B 3.3.3.1-5 and B 3.3.3.1-6 - Primary Containment Pressure is numbered Function 10 instead of Function 12 and Suppression Pool Water Temperature is numbered Function 11 instead of Function 13.
- NUREG-1434, Page B 3.6.3.2-5 - Added revised Specification number in the upper right corner and eliminated an extraneous number on the bottom right corner.


Attachment B contains TSTF-429, Revision 2, "Ice Mass Determination Surveillance Requirements," which is provided for NRC review. This revision addresses NRC concerns identified in a meeting with the Ice Condenser Utility Group on May 13, 2003.

Attachment C contains TSTF-450, Revision 0, "Staggered Integrated ESFAS Testing (WCAP-15830)," which is provided for NRC review. The referenced Topical Report was previously submitted to the NRC and is currently undergoing NRC review.

As stated your letter to Anthony Pietrangelo, NEI, dated June 2, 2003, TSTF-429 and TSTF-447 will continue to be reviewed under fee exemption. Any NRC review fees associated with the review of TSTF-450 should be billed to the Westinghouse Owners Group. The details of billing NRC review fees for Travelers are currently being finalized. If there are any additional considerations associated with invoicing NRC review fees for Travelers, we will inform you. In accordance with our discussions regarding review fees for Travelers, please track any cost of NRC review for this Traveler, and any subsequent revisions, separately from other review activities, such as the Topical Report review. This will assist the TSTF in estimating the cost of NRC review of future Travelers.
