NEVADA NUCLEAR WASTE STORAGE INVESTIGATIONS (NNWSI) PROJECT WEEKLY HIGHLIGHTS FOR THE WEEK ENDING JULY 17, 1987

I. Critical Items Status

A. Stop-Work Orders

Lawrence Livermore National Laboratory (LLNL)—The status of the five remaining scientific investigation planning (SIP) documents and their associated quality assurance level assignments (QALAs) requiring Waste Management Project Office (WMPO) approval is as follows:

SIPs	approved by WMPO	-	5
SIPs	in process		5

Three of the SIPs in progress have been submitted to WMPO for review. The review date is not yet scheduled, but will occur during July.

U.S. Geological Survey (USGS)—The four generic conditions identified for rescinding the stop-work order on technical and scientific activities have been satisfied. Hence, the lifting of the stop-work order is now incremental with the VMPO approval of the SIPs and associated QALAs. The status of the SIPs and QALAs is as follows:

SIPs approved by WMPO	3
SIPs submitted to WMPO for review/approval	28
SIPs in process for current investigations	23

Six of the SIPs in process have been submitted to WMPO for review. No tentative review has been scheduled as yet.

B. Site Characterization Plan (SCP)

Comment resolution of remaining sections of SCP Chapter 8 have been closed out with the completion of U.S. Department of Energy Headquarters (DOE/HQ) comment resolution workshops. Final SCP Overview Committee agreements were achieved during the workshops relative to sections 8.2 and 8.5, and both sections are undergoing revision in preparation for a preconcurrence review by DOE/HQ staff prior to incorporation into the final concurrence draft of the SCP. Aside from Sections 8.2 and 8.5, the SCP text is corporation (SAIC).

A recent agreement between DOE/HQ and the WMPO relative to the definition of prototype tests or activities will impact the current text of the SCP. Thus, various project participants have been requested to visit SAIC in Las Vegas, Nevada, to modify the effected text.

The schedule for study plan preparation is being revised to be consistent with the SCP production schedule.

C. Core Sample Management

The Sample Management Facility (SMF) staff completed a prototype of the proposed data-base structure for all sample handling in the SMF and reviewed the SMF records handling procedures with the Information Management System staff. Reviews of final Title II design drawings for Warehouse #2 have also been completed.

II. Significant Accomplishments/Information Items

A reorganization of the U.S. Department of Energy Nevada Operations Office (DOE/NV) was announced this week. Significant changes include the following:

- 1. The VMPO reports directly to the Office of the Manager of DOE/NV.
- 2. D. L. Vieth is reassigned to be Acting Deputy Assistant Manager in the Office of Assistant Manager for Environment, Safety, and Health.
- 3. The position of Director, WMPO, is currently vacant on the organization chart. M. P. Kunich, Deputy Director, WMPO, is detailed as Acting Director, WMPO.

Other DOE/NV organizational changes were also announced that do not affect the program.

Don Vieth and Environmental staff visited San Francisco on July 13 to meet with the U.S. Environmental Protection Agency (EPA). The purpose of this meeting (the first of its kind) was (1) to open communications with the EPA and establish contacts between that agency and the NNWSI Project relative to technical matters, (2) to introduce EPA staff to various aspects of the high-level radioactive waste disposal issue, (3) to discuss current and planned NNWSI Project site characterization activities, and (4) to investigate environmental regulatory compliance issues.

Don Vieth appeared on a local television interview program ("A.M. Southern Nevada") on July 16 to discuss aspects of the NNWSI Project.

Fenix & Scisson, Inc. (F&S) has reported their submittal, to the WMPO, of Exploratory Shaft Facility (ESF) Special Study Report No. 5 (Revision No. 1), "ESF Hoisting System". F&S has also transmitted the Proposed Layout for Excavation Effects Test to the WMPO.

A Government Accounting Office (GAO) audit was conducted on July 9 and 10. The GAO auditors, commissioned by the Senate Committee on Energy and Natural Resources, were interested in the projected budgets for site characterization since 1981. An additional GAO audit of the NNWSI Project will be conducted during the last week of July. This subsequent audit will involve providing answers to questions relative to regulatory and institutional issues and may not include a visit by the audit team.
