# NRC STAFF RESPONSE TO NOTIFICATION OF FANSTEEL, INC. IN CONNECTION WITH SHOW CAUSE ORDER

#### INTRODUCTION

Pursuant to 10 C.F.R. § 2.1237, the NRC Staff hereby responds to "Notification of Fansteel, Inc. In Connection with Show Cause Order" filed on July 15, 2003 (Notification).<sup>1</sup> As discussed further below, the Staff does not oppose Fansteel's request to suspend the current schedule in the above-captioned proceeding.

#### BACKGROUND AND DISCUSSION

On July 9, 2003, the Presiding Officer designated in the above-captioned proceeding issued an Order directing the State of Oklahoma to show cause why, in light of Fansteel's withdrawal of its decommissioning plan (DP), why this proceeding should not be dismissed. "Show Cause Order (Dismissal of Proceeding)" July 9, 2003. On July 15, 2003, Fansteel filed its Notification. In Notification Fansteel requested that the Presiding Officer suspend the current schedule of responses to its July 9, 2003, show cause order pending further notification by Fansteel of its planned actions with respect to the DP. According to Fansteel, it may decide to resubmit the DP to the NRC for consideration or liquidate the company without seeking approval of a DP.

Notification at 2. Fansteel committed to notify the Presiding Officer, the State and the NRC staff

no later than July 25, 2003 of its decision on whether to resubmit the DP to the NRC. Id. Also on

July 15, 2003, the State of Oklahoma filed its objection to Fansteel's Notification. "State of

Oklahoma's Objection to Notification of Fansteel, Inc., In Connection with Show Cause Order."

The Staff does not oppose Fansteel's request to suspend the current schedule to respond

to the Show Cause Order until July 25, 2003. In addition, pursuant to 10 C.F.R § 2.1213, the Staff

hereby indicates its desire to participate as a party to the adjudication.
