As a result of the ICE Meeting held in August, Weston representatives visited Parson-Brinckerhoff and Bechtel in San Francisco. SNL had appropriate representation at the meeting. Weston will prepare an

independent cost estimate to set the stage for resolving cost estimating differences. ICE will then go to San Francisco on September 24 to try to reconcile their cost estimates with the Weston and NNWSI cost estimates.

After a one-year hiatus, the Exploratory Shaft Facility (ESF) status meetings have resumed. The status meeting was held September 5 at the NTS and discussed schedules, construction strategy for the second shaft, and impact on contractors due to the second shaft.

The NRC met with NNWSI Project participants and WMPO on August 31 to discuss a proposed NRC Information Management System and Issues-Tracking System. The Project recognizes that if we are to meet NRC requests for information management, it will result in a significant expenditure. A plan is being prepared to implement the NRC-requested system which will include coordination of the DOE Management Information System with the NRC Information Management System.

Sleeping quarters will be provided for NRC Data Review Panel members at Mercury during the week of September 17 while they are conducting the Geology Data Review at NTS.

Don Vieth made a presentation to the Nye County Commissioners in Tonopah on September 6 describing the status of the NNWSI Project.
