

The purpose of this modification is to: (1) exercise Option Year One of the subject contract; (2) provide funding in the amount of \$12,048.00 for performance of work under Option Year One; and (3) extend the period of performance from September 02, 2002 to August 31, 2004. Accordingly, the contract is modified as follows:

1. Option Year One, CLIN 3 and 4, are hereby exercised. As a result, the obligated and ceiling amount of the subject contract is hereby increased by \$12,048.00 from \$58,371.36 to \$70,419.36
2. Under Contract Clause A .11 - Duration of Contract, the second sentence is hereby deleted in its entirety and replaced with the following:

"The lease period will begin on 9/1/02 and will expire unless renewed on 8/31/04."

All other terms and conditions of the contract, remain unchanged.
