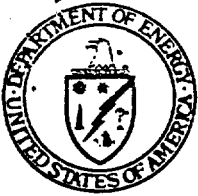

### I. Critical Item Status

#### A. Site Characterization Plan (SCP) Progress Reports

Yucca Mountain Project participants are continuing to prepare their input to the project bi-annual status report. An administrative procedure is under development to define the process for input preparation.

#### Comment Response Summary

Work continued on final editing and cross-referencing of responses to comments made on the Consultation Draft of the SCP. The comment response package for the U.S. Geological Survey was completed this week. The comment response package for the State of Nevada is scheduled for completion by the end of next week.

B. Core Sample Management

Staff at the Sample Management Facility (SMF) initiated the reprocessing of core from USW G-4 and UE-25 A#1 boreholes.

A tour of the SMF was conducted for a reporter from Southam News, Washington D.C., who writes for 16 Canadian newspapers.

The Sample Overview Committee meeting was held in Las Vegas, Nevada.

C. Quality Assurance (QA)

The verification draft of the Yucca Mountain Project Office (Project Office) Software Quality Assurance Plan was submitted to Project Office Reviewers. The scheduled completion date for the verification review is October 9, 1989.

QA Audit 89-5 of Reynolds Electrical & Engineering Co., Inc. was completed this week.

D. Exploratory Shaft Facility (ESF)

A management review of Fenix and Scisson of Nevada (FSN) Title II general arrangement drawing package No. 1 was conducted.

The annotated outline and schedule for an implementation plan for the "Evaluation of Alternatives for Configuration and Construction of the Exploratory Shaft Facility (ESF)," based on the ESF being part of the repository was revised based on comments received. Staff developed a draft responsibility matrix for writing the plan and performing the evaluation, along with initiating the actual writing of sections of the plan.

Integrated Data System Readiness Review meetings will be held the week of October 9. All of the review questions have been addressed and supporting evidence for the responses to the questions have been collected.

E. Long Range Planning and Project Planning and Control System (PACS)

Preliminary PACS data has been received from Holmes & Narver, Inc. Lawrence Livermore National Laboratory, and Los Alamos National Laboratory. Data entry into PACS will be initiated later this month.

Resource estimating of data base activities by all participants is continuing. These activities include training of participant personnel and support of participants in preparing input for the PACS.

F. Environmental Permitting

The Biological Assessment (BA) has been completed and is undergoing final project review. The BA is expected to be transmitted to the U.S. Fish and Wildlife Service next week.

G. Nuclear Waste Technical Review Board (NWTB) Meetings and Interactions

There were no significant interactions or meetings with the NWTB this week.

II. Significant Accomplishments/Information Items

As part of project preparations for the October 31, 1989, formal meeting on interactions scheduling with the U.S. Nuclear Regulatory Commission (NRC), staff initiated the development of a list of meeting topics and scopes, and prepared a draft list and circulated it for review and comment. The revised list will be transmitted to U.S. Department of Energy/Headquarters (DOE/HQ) for further review and comment.

A Yucca Mountain Project Update meeting was held in Carson City, Nevada, on September 28, 1989. Meeting attendance was estimated at 100 persons.
