I have the honour to forward the enclosed draft Safety Series Report, "IAEA Safety Standards for Underground Disposal of High-level Radioactive Wastes" for review by your competent authorities. These Safety Standards have been prepared with the objective of providing the Member States with basic guidance on protection of humans and the environment from the hazards associated with deep geological disposal of high-level radioactive wastes.

The document was prepared by the common IAEA mechanism with consultants, advisory group and technical review committee members who have thoroughly reviewed the text of the document. The English version of the document is enclosed; however, for those Member States for which the official language of correspondence is French, Russian or Spanish, the appropriate version will be mailed after its completion.

The Agency's Secretariat is planning to present the document to the Board of Governors in June 1988 and, therefore, needs to receive any comments on the draft by 15 March 1988. The responsible IAEA officer for this report is Mr. I.F. Vovk of the Division of Nuclear Fuel Cycle. He may be contacted for further information in connection with the subject.
