7. DISCUSSION OF ISSUES IDENTIFIED AT SECOND MEETING OF ISAG (Paris, June 1987)

- Participants are requested to provide a 2-3 page written outline (25 copies) of the site characterisation objectives and requirements of their respective national programmes, identifying in particular the rationale for these objectives and requirements, and the processes of implementation. This information on national approaches will be valuable in the discussions on general or international aspects of site characterisation.

b) Consideration of how Boundary Conditions are Identified for In-Situ Experiments

- Discussion of general approaches to this issue, and of the need for any initiatives to be developed by ISAG.
- A summary of relevant information obtained from the questionnaire on interaction between experiments and modelling will be prepared and presented by the Secretariat, to facilitate discussion.
