YUCCA MOUNTAIN PROJECT WEEKLY HIGHLIGHTS FOR THE WEEK ENDING AUGUST 4, 1989

I. Critical Items Status

A. Site Characterization Plan (SCP) Progress Reports

Work is continuing on the development of a guidance package for preparing input to the Yucca Mountain Project Biannual Status Report (BSR). The report will be prepared and issued on a schedule compatible and synchronized with the Semiannual Progress Report (SPR), currently prepared by the U.S. Department of Energy/Headquarters (DOE/HQ). The BSR will serve as primary input to the higher-level programmatic summary contained in the SPR. The BSR will also report technical progress and status at a lower level of detail, thereby allowing for greater latitude in reporting details of technical progress found inappropriate for the SPR.

Comment Response Summary

An Integration Group meeting was held in Las Vegas on August 2-3, 1989. The purpose of the meeting was to finalize responses to comments made on the Consultation Draft of the SCP by the U.S. Geological Survey, the State of Nevada, and the Edison Electric Institute.

SCP Study Plan Status: August 4, 1989

The Comment Resolution meeting for Study Plan 8.3.1.15.1.2, "Laboratory Thermal Testing," was held this week in Washington, D.C. Study Plans 8.3.1.3.6.1 and 8.3.1.3.6.2 were received by the Yucca Mountain Project Office (Project Office) and are undergoing a screening review in accordance with Project Administrative Procedure 1.10Q. Study Plan 8.3.1.3.2.1, "Mineralogy, Petrology, and Chemistry Along Transport Pathways," is in the final approval stage at DOE/HQ.

B. Core Sample Management

A tour of the Sample Management Facility (SMF) was included in an U.S. Nuclear Regulatory Commission (NRC) hydrology field trip.

Staff completed the execution of the Curatorial Sample Inventory Tracking System Verification Plan. This task completed the quality assurance (QA) software verification activities for the SMF. The QA surveillance of the SMF was also completed.

C. Quality Assurance

Surveillance YMP-SR-89-115 of the Radiological Monitoring Program was completed.

At this week's Assistant Technical Project Officer's Exploratory Shaft Facility Status meeting, QA staff reported on previously assigned actions items. These action items involved the EG&G Quality Assurance Program Plan for the Integrated Data System; the issuance of a letter approving the grading package for the soils and rock investigation; the surveillance plan for Holmes & Narver's (H&N) 50 percent completion of the site preparation and mobilization design package; and the release of Sandia National Laboratories (SNL) to start Title II work, which was determined by the acceptance of the design control-related Standard Deficiency Reports. No new action items were assigned to QA staff.

All comments on the Fenix and Scisson of Nevada (FSN) Software Quality Assurance Plan have now been resolved. A formal letter has been sent to FSN that includes the comments from the initial review.

D. Exploratory Shaft Facility (ESF)

Benchmark 6 of the ESF Subsystems Design Requirements Document has been upgraded. A change request will be submitted to the Change Control Board after approval by SNL.

A meeting was held with DOE/HQ and Weston to resolve comments on the waste package strategy document. All comments were resolved at this meeting.

Project Administrative Procedure 5.18Q, "Design Control," is in the process of being signed for issuance.

E. Long Range Planning (LRP) and Project Planning and Control System (PACS)

The list of assumptions for LRP was revised this week based on Project Office and DOE/HQ workshops held last week in Las Vegas. These assumptions, as well as a list of action items from the workshop, were transmitted to DOE/HQ this week.

The review and scrubbing of networks by project participants will continue through next week.

Guidance to the participants regarding resource loading was drafted this week for project management review.

PACS training was held for H&N. Other participants will receive training in the future.

The Project Manager approved the July 1989 version of the Work Breakdown Structure (WBS) Dictionary. A letter is being drafted to transmit the WBS dictionary to project participants.

F. Environmental Permitting

A response to the Nevada Department of Environmental Protection's (NDEP's) letter, dated May 19, 1989, regarding the Yucca Mountain Project Air Quality Permit for land disturbance, was sent to the NDEP on July 11, 1989. That letter requests that the air quality permit be issued at this time. No response has been received to date.

II. Significant Accomplishments/Information Items

Prototype dry drilling, Phase 1C, was initiated at a second location near Milford, Utah. The first location at the Milford site was abandoned due to the presence of an excessive amount of perched water.

Project institutional staff updated the exhibit schedule for 1989. Preliminary arrangements were also made to staff the project table-top exhibit at the Nevada State Fair, August 8-13, 1989.

Details were finalized with the DOE/Nevada Operations Office (NV), Office of External Affairs to have the Yucca Mountain Story brochure printed at Reynolds Electrical & Engineering Co., Inc.
