YUCCA MOUNTAIN PROJECT WEEKLY HIGHLIGHTS FOR THE WEEK ENDING
SEPTEMBER 22, 1989

I. Critical Items Status

A. Site Characterization Plan (SCP) Progress Reports

Project participants are continuing to prepare their input to the project biannual status report and the second semiannual progress report (SPR). A draft Chapter 6 to the SCP Management Plan was prepared to describe the process of preparing input to the SPRs.

Comment Response Summary

Work continued on final editing and cross-referencing responses to comments on the SCP Consultation Draft. Comment response packages for the State of Nevada and the U.S. Geological Survey comments are expected to be completed by the end of September. A schedule for preparing responses to comments on the SCP was drafted.

SCP Study Plan Status: September 12, 1989

A joint U.S. Department of Energy/Headquarters (DOE/HQ)/Yucca Mountain Project comment resolution meeting is scheduled for Study Plan 8.3.1.8.1.1 (probability of a volcanic eruption penetrating the repository). The meeting will take place on Wednesday, September 27, 1989, in Las Vegas, Nevada.

B. Core Sample Management

Staff continued processing Utah prototype borehole samples at the Sample Management Facility.

C. Quality Assurance (QA)

Criteria 3, Design Control, was one area reviewed last week in the Yucca Mountain Project Office (Project Office) Audit 89-3 of Sandia National Laboratories (SNL). The audit team assigned to this area identified several concerns, which were immediately addressed by the SNL staff. The design control activities within SNL were determined to be effectively in compliance with QA requirements.

QA auditors are preparing for the Readiness Review of the Integrated Data System at EG&G. No Title II design work may begin until all action items assigned EG&G have been completed.

D. Exploratory Shaft Facility (ESF)

Project staff reviewed the HQ task plan on "Evaluation of Alternatives for Configuration and Construction of the ESF" and assisted in development of an annotated outline for an implementation plan for the task.

E. Waste Package

Project staff completed informal review of a Cold Checkout Test Plan for the Prototypical Consolidation Demonstration Project.

Project staff continued development of the Waste Package Program Plan.

F. Long Range Planning (LRP) and Project Planning and Control System (PACS)

Resource estimating of LRP network activities continues with special training sessions being conducted as needed for participants. Sessions for Los Alamos National Laboratory and SNL have been completed. Participants have begun submitting PACS summary account input.

Programming for APECS 8000 screen and menu formats is ongoing.

G. Environmental Permitting

Work continues on the Desert Tortoise Biological Assessment (BA). The BA is scheduled for completion by the end of September 1989.

H. Nuclear Waste Technical Review Board (NWTBR) Meetings and Interactions

There were no significant interactions nor meetings with the NWTBR this week.

II. Significant Accomplishments/Information Items

Project staff developed a strategy for discussions with the U.S. Environmental Protection Agency and the U.S. Nuclear Regulatory Commission regarding changes to regulations on releases of Carbon-14.
