The next DOE Meeting with States and Indian Tribes will be held October 1, 1987, at the Grand Kempinski Hotel (formerly the Registry Hotel), 15201 Dallas Parkway, Dallas, Texas.

A block of rooms has been reserved at \$55/Single and \$65/Double per night (plus 9% tax). You should contact the hotel directly on (214) 386-6000 to make reservations. Please indicate to the reservations staff that you will be attending the U.S. Department of Energy meeting. PLEASE MAKE YOUR RESERVATION EARLY. We lose our block of rooms on September 8. Reservation requests after September 8 are subject to hotel availability. Your reservation must be secured by a one-night deposit or guaranteed with a major credit card number.

Travel time from the airport is approximately 25 minutes. The hotel offers complimentary parking. VIP Transport provides continuous shuttle bus service from Dallas/Fort Worth Airport (D/FW) to the hotel from 8:30 a.m. until 9:50 p.m. You should proceed to the "Bus and Limo Pick-up" area located outside of baggage claim and look for a medium blue bus with gold lettering. The fare is \$10/one-way per person or \$8/one-way per person in groups of four or more. A taxicab ride from D/FW Airport will average \$20-\$25 for a one-way trip.
