SUBJECT: CLARIFICATION OF JANUARY 10, 1989 LETTER ON QUALITY ASSURANCE

In my letter to you dated January 10, 1989 I discussed the fact that there may be indications the U. S. Department of Energy (DOE) is interpreting the requirements of the Code of Federal Regulations, Title 10, Part 50, Appendix B (10 CFR Part 50, Appendix B) too strictly. The letter continued by stating that the approach outlined in the "Nevada Nuclear Waste Storage Investigation Quality Assurance Plan," (NNWSI/88-9) was one acceptable method for meeting 10 CFR Part 50, Appendix B and that the DOE contractors will develop the detailed plans and procedures that will translate the general requirements of 10 CFR Part 50, Appendix B into working level documents.

Upon further examination of the January 10, 1989 letter, I believe that some clarification is needed. I am concerned that DOE may have interpreted the staff as saying that the approach contained in NNWSI/88-9, Revision 2 was too strict, and therefore, unacceptable. This was not the intent of the letter. As indicated in the agenda for the upcoming February 23, 1989 QA meeting, the staff and DOE will be discussing this further.
