Following below is a list of previously identified concerns and issues which have some generic aspect to them and which have not been resolved or, where resolution was initiated, such resolution resulted in ineffectual or unsatisfactory actions in my judgement. Judgements are based on my current knowledge of the status of events, which knowledge being incomplete because of spotty or no communications with cognizant staff during the last five months. Hence some of the items identified, for example, issues raised as comments on the Quality Assurance Review Plan, may have been resolved by this time.

The item numbers preceded by "*****s" are in my judgement the more significant items with respect to assuring a successful completion of licensing, with fewer "*'s" indicating less significance.
