Dear Mr. Gertz:

The DOE/YMP quality assurance audit of the U.S. Geological Survey held on August 14-18, 21-23, 1989 was performed contrary to the requirements of the DOE 88-1/QMP-18-01 and violated the NQA-1 requirements for "sufficient authority and organizational freedom" for audit personnel (Supplement 185-1).

The new position of Audit Manager (see attached) is not included in procedure QMP-18-01. The duties and responsibilities of the Audit Manager as indicated in the attachment clearly negate the authority and organizational freedom of the Audit Team Leader/Lead Auditor as defined in QMP-18-01 and NQA-1.

The presence of Jim Blaylock on this audit as both the designated Audit Manager and as an auditor who answers to the Lead Auditor was a clear conflict of interest. Also, Mr. Blaylock is still listed as the Project Quality Manager for DOE/YMP and he clearly should not have served on this audit in these two capacities.

Given the procedural violations and the obvious conflict of interest, we believe Audit 89-4 of the USGS to be invalid and that an independent audit should be performed in accordance with approved plans and appropriate Quality Assurance standards.
