The purpose of this modification is to de-obligate funds in the amount of \$3,325.43; thereby decreasing the obligated amount of the contract from \$527,000.00 to \$523,674.57. Accordingly, the contract is hereby modified as follows:

Under Section B.4, "CONSIDERATION AND OBLIGATION-WORK ORDERS," the second sentence in paragraph "(b)" is revised to read as follows:

"(b) The amount currently obligated on this contract is \$523,674.57."

All other terms and conditions of the contract remain unchanged.
