SUBJECT: CHANGE OF CORPORATE NAME

Dear Ms. Milicic:

This letter is in response to your letter dated March 26, 2003, requesting to change the corporate name for Registration Certificates NR-112-D-102-B, NR-112-D-103-B (which was listed, through an oversight, in the letter as NR-112-D-106-B), and NR-186-D-117-B . We have discussed, in a telephone conversation on August 7, 2003, the scope of your intended activities regarding these devices and understand that (1) BSI Instruments no longer distributes new devices that are registered in Registration Certificates NR-112-D-102-B and NR-112-D-103-B; and (2) BSI Instruments continues to fabricate and distribute the devices that are registered in Registration Certificate NR-186-D-117-B.

Therefore, based on our telephone conversation, we intend to issue inactive registration certificates, with your new corporate name, to supercede Registration Certificates NR-112-D-102-B and NR-112-D-103-B. These certificates will have different numbers. With inactive registrations, you may continue to service the units that had been previously distributed. In order for us to issue the inactive registrations, we need the following information for the devices that are registered in NR-112-D-102-B and NR-112-D-103-B:

- the total number of the products sold to date; the number of products still in use (to your best estimate);
- the delineation of the services (including source replacement, repair, refurbishment and availability) that BSI Instruments will still provide to users of the products or the identification of an entity that will provide services;
- a commitment that BSI Instruments will no longer commercially distribute the products;
- verification that no changes were made to the products since the initial registration or last amendment; and
- a confirmation that BSI Instrument is the successor of Apgee Corporation, who is currently listed as the distributor.

Regarding Registration Certificate NR-186-D-117-B, please confirm that BSI Instruments is the successor of Berthold Systems, Inc., who is currently listed as the manufacturer/distributor.

Please submit the requested information within thirty days of the date of this letter. If we have not received complete information within thirty days of the date of this letter, we will consider your application as having been abandoned by you. This is without prejudice to the submission of a complete application.
