Co., Phoenix Aerospace Corp. and American Sintered Technologies, Inc., each as a debtor and debtor-in-possession (collectively, the "Debtors"), together with the Official Committee of Unsecured Creditors of Fansteel Inc. (the "Committee") as a co-proponent, are seeking approval of the disclosure statement with respect to their proposed joint plan of reorganization, dated July 24, 2003 (the "Disclosure Statement"), from the United States Bankruptcy Court for the District of Delaware (the "Court") pursuant to and in accordance with 11 U.S.C. §1125.


