Dear Mr. Gertz:

Action Item 18 in Reference 1 requested the DOE to provide the data (e.g., RQD's, stresses, hydraulic conductivities) used to obtain the results on the damaged zone model for tuff presented by the DOE during the August 1985 NRC-NNWSI Project Meeting. In your letter to J. Linehan dated February 11, 1988 (Ref. 2), you stated that DOE intends to use a different modified permeability zone model for the revised performance analysis. The data necessary to support this model was stated to be included in Reference 3.

The NRC staff has reviewed the information provided by the NNWSI Project (Ref. 2 and 3) in response to Action Item 18. Based on this review, we conclude that the data necessary to support the revised modified permeability zone model has been adequately included in Reference 3. Therefore, we consider this Action Item to be closed.
