INSTRUCTIONS TO STUDENTS

ACCEPTANCE: This is to advise you that those individuals in Enclosure 1 have been accepted for participation in the training course (G-108) "Inspection Procedures." This course is scheduled to be presented September 29-October 3, 2003, at the Courtyard Orlando Downtown, 730 North Magnolia Avenue, Orlando, Florida 32803, Telephone: (407) 996-1000.

COURSE: This course will be conducted beginning at 8:00 a.m. and end at 4:00 p.m. each day except for Friday, October 3, 2003, when the class is scheduled to end at 12:00 noon.

LODGING AND TRAVEL: You should plan to arrive on Sunday, September 28, 2003 and depart on Friday, October 3, 2003. Participants must make their own lodging and travel arrangements. **It is recommended that you make your hotel arrangements at the Courtyard Orlando Downtown where the training is being held.** A special per diem rate of \$85.00 per night which includes a full breakfast buffet is included. You need to reserve your room under "NRC Inspection Procedures Course" by September 19th. The sales contact is Gabriela Gonzalez.
