SUBJECT: NRC INSPECTION REPORT 50-255/97003(DRS)

Dear Mr. Palmisano:

On March 20, 1997, the NRC completed an inspection of your implementation of 10 CFR 50.65, "Requirements for Monitoring the Effectiveness of Maintenance at Nuclear Power Plants" (the maintenance rule) at the Palisades Nuclear Generating Plant. The enclosed report presents the results of that inspection.

Your program for implementing the requirements of the maintenance rule followed the guidance provided in NUMARC 93-01, "Industry Guideline for Monitoring the Effectiveness of Maintenance at Nuclear Power Plants," dated May 1993, which was endorsed in Regulatory Guide 1.160, "Monitoring the Effectiveness of Maintenance at Nuclear Power Plants," dated January 1995. Your program met the requirements of the maintenance rule; no violations of NRC requirements were identified. We noted that your program for structure monitoring was comprehensive and well executed. However, we were concerned by weaknesses identified in the administration of reliability criteria, specifically lack of timeliness in both completing Maintenance Preventable Functional Failure evaluations and in identifying that performance criteria had been exceeded.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
