Dear Mr. Kingsley:

An NRC inspection was conducted April 14 - 18, 1997, at your Browns Ferry 1, 2 and 3 reactor facilities. This was an inspection of your implementation of the requirements of 10 CFR 50.65, "Requirements for Monitoring the Effectiveness of Maintenance at Nuclear Power Plants" [the Maintenance Rule]. The enclosed report presents the results of that inspection.

Your program for implementing the requirements of the Maintenance Rule followed the guidance provided in NUMARC 93-01, "Industry Guideline for Monitoring the Effectiveness of Maintenance at Nuclear Power Plants," Revision 2, dated April 1996, which was endorsed in Regulatory Guide 1.160, "Monitoring the Effectiveness of Maintenance at Nuclear Power Plants," Revision 2, dated March 1997. The inspection concluded that your program was comprehensive and was being effectively implemented.

Strengths were noted in the conduct of Expert Panel Meetings, your self-assessments of the program, and your efforts to adjust performance criteria and re-evaluate system performance based on actual operating experience. Minor weaknesses were noted in your risk matrix used for removal of equipment from service during power operations. One unresolved item was identified concerning your implementation of the Maintenance Rule on Unit 1.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room (PDR).
