DOE/Headquarters, Office of Civilian Radioactive Waste Management, Germantown, Maryland has announced the following technical workshops scheduled between DOE-Nevada Operations Office, Waste Management Project Office, and the NRC-Division of Waste Management, High-Level Waste Technical Development Branch. The purpose of these meetings is to consult and exchange technical information in pursuant to provision in the "NRC/DOE Procedural Agreement, June 29, 1983" and concern geotechnical investigations of Yucca Mountain, Nevada, as a potential site for a repository to permanently store high-level radioactive waste in accordance with the Nuclear Waste Policy Act, 1982.
