I, Laticia Hill, being first duly sworn on oath, states as follows:

1. I am an adult individual over the age of 18. The following statements are based upon personal knowledge, and if called upon to testify as a witness, I could competently testify thereto.


2. I am employed at MarCap Vender Finance Corp. ("MarCap"), which now owns Fisher Anderson, LC ("Fisher"). Marcap is located at 9665 Chesapeake, San Diego, California. At MarCap, I hold the position of Portfolio Administration and Default Manager.

3. In my capacity as Portfolio Administration and Default Manager, I am familiar with the books and records of Fisher. On or about June 5, 2001, Daniel Langstraat, as the CFO of Fansteel Washington Manufacturing, Inc., executed an Equipment Lease Agreement (hereinafter the "Lease") in favor of Fisher, for the lease of (1) 20 User License for INFISY Software, more specifically described in the Lease, and 10 Bar Code Laser Guns (together the "Equipment").

4. On or about June 21, 2001, Fisher caused to be filed a UCC Financing Statement with the Secretary of State of Iowa, in order to secure the Equipment.


5. The current gross balance due under the Lease from Fansteel Washington Manufacturing, Inc. is \$99,413.28. The principal balance is \$73,098.00, and the interest to date is \$26,315.28. 
