


The purpose of this modification is to increase the ceiling amount of the delivery order by \$72,111.00, from \$217,794.00 to \$289,905.00, as a result of a error made at the time the delivery order was originally awarded. In addition, the amount obligated with respect to Delivery Order No. 1 is increased by \$72,111.00, from \$217,794.00 to \$289,905.00. Accordingly, the contract is hereby modified:

1. Contract transmittal letter dated February 13, 2003, Paragraph No. 2, second sentence, is deleted and substituted with the following in lieu thereof:

"Delivery Order No. 1 will be in effect for 12 months from the effective date of the subject contract with a ceiling of \$289,905.00."

2. Section B.2, "Consideration and Obligation -- Delivery Order (Jun 1988)," the first sentence of paragraph (b), as modified in Modification No. 1, is deleted and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this delivery order is \$289,905.00."

ADM002 (REV. 10-83)

The purpose of this modification is to:

1. Confirm verbal authorization provided to HELLIER, on June 24, 2003, to continue performance beyond June 30, 2003 with a temporary ceiling of \$10,000.00.
2. Exercise option year one of this contract in accordance with Federal Acquisition Regulation Clause 52.217-9, entitled, "Option to Extend the Term of the Contract", thereby extending the period of performance through June 30, 2004. As a result of this action, the contract ceiling is hereby increased by \$95,840.00, which is inclusive of the \$10,000.00 temporary ceiling authorized on June 24, 2003, from \$119,340.00 to \$215,180.00.
3. Provide incremental funding in the amount of \$19,820.00, hereby increasing the obligated amount of this contract from \$66,840.00 to \$86,660.00.

Accordingly, this contract is modified as follows:

1. Section **B.12 PERIOD OF PERFORMANCE** is hereby DELETED in its entirety and replaced with the following in lieu thereof:

"The period of performance of this contract shall be from July 1, 2002 through June 30, 2004. The term of this contract may be extended at the option of the Government for three (3) additional one year periods."

2. Under Section **C - CONTRACT CLAUSES**, ADD the following Sub-Section:

**"C.12 OBLIGATION AND CONSIDERATION - DELIVERY ORDERS (JUN 1988)**

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$215,180.00. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

(b) The amount presently obligated with respect to this contract is \$86,660.00. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated

with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."
