SUBJECT: PUBLIC MEETING SUMMARY ON THE REACTOR OVERSIGHT
PROCESS MONTHLY MEETING HELD ON AUGUST 21, 2003

On August 21, 2003, a Reactor Oversight Process (ROP) public meeting was held at the Two White Flint North Building, Room T2B3. Agenda topics discussed include updates on the industry's self-assessment program, ROP inspection procedure consolidation status, status of the draft significance determination process (SDP) revisions, scrams with loss of normal heat removal performance indicator (PI) generic issue, mitigating systems performance index (MSPI) overview, and frequently asked questions (FAQs). A three hour MSPI overview status presentation was added to the meeting agenda. The August 20, 2003 public meeting on the MSPI pilot activities was canceled.

The Scrams w/LONHR PI generic issue was also discussed with regard to the staff presentation on a new option (attachment 3) on how to count scrams with losses of normal heat removal. The staff's proposal is to count all scrams where there were main feedwater and condensate problems, main steam isolation valve closures and losses of condenser vacuum, where any one or more of the above systems did not function as designed after the scram and that it affect all operating trains. Industry agreed to consider the staff's proposal and respond by the September 2003 meeting.

During the afternoon portion of the public meeting, Office of Research (RES) gave a three hour presentation overview of the MSPI pilot. After the presentation, industry stated that they have agreed in principle to almost all of the technical fixes proposed by the staff for the invalid and insensitive system issues. Although additional work remains, the ROP Working Group will focus on these open issues during the upcoming September 24, 2003 public meeting on the MSPI.

The remainder of the day was devoted to frequently asked questions (FAQs) on the Pls. The next combined meetings of the MSPI and ROP Working Groups is scheduled for August 20 and 21, 2003, respectively.
