CFC LOGISTICS, INC. UPDATE TO PRESIDING OFFICER REGARDING DOCUMENT PRODUCTION

CFC Logistics, Inc. (CFC), by its undersigned counsel of record, hereby submit this Update to Presiding Officer Regarding Document Production in accordance with the Presiding Officer's Order of August 27, 2003, requiring that certain documents be made available to Petitioners' counsel of record by Thursday, August 28, 2003 at noon.

Counsel for CFC and representatives of CFC and Gray*Star, the proprietor of some of the documents to be produced, agreed upon and delivered a draft protective order to counsel for Petitioners via electronic transmission at 11:43 am on Wednesday, August 27, 2003. After not receiving any communications from counsel for Petitioners that day, by electronic transmission dated 10:35 am, Thursday, August 28, 2003, counsel for Petitioners informed CFC that he would not be available until the afternoon of August 28, 2003 for consultation regarding the aforementioned proposed protective order.

Therefore, it appears that the Presiding Officer's deadline for production of documents of August 28, 2003 at noon will not be met because counsel for Petitioners has been unavailable for consultation on a protective order prior to such deadline.

In the interim, CFC has requested that NRC Staff deliver the aforementioned documents to Petitioners' counsel of record immediately after receipt of a properly executed protective order from CFC. NRC Region I counsel, Karl Farrar, agreed to deliver such documents so long as NRC Staff received a letter from CFC authorizing such delivery. Such authorization was executed and delivered to Mr. Stephen H. Lewis, counsel for NRC Staff on Thursday, August 28, 2003 at 7:15 am. Thus, the aforementioned documents will be distributed to counsel for Petitioners by NRC Staff after a protective order is executed and delivered to NRC Staff.
