Subject: Comments on Monthly Report for FIN A1165 (June 1986)

I have received your report summarizing the activities during the month of June for FIN A1165. I have reviewed the report and have the following comments:

1. Under Task I Sandia indicated that while both Aerospace and Golder have recommended that DOE and other codes such as WAPPA and ORIGEN be included in the LAM that no NRC documentation is available for these codes. I am investigating whether the NRC has documentation on the ORIGEN code and possibly WAPPA. I will notify you if such information is available. If there are other codes for which you need information please provide the code names and I will attempt to provide the needed documentation.
2. Under Task II, Sandia provided comments on the DOE report "Multiattribute Utility Analysis of Sites Nominated for Characterization for the First Radioactive-Waste Repository -- A Decision-Aiding Methodology." These comments will be incorporated into the NRC's on-going review of the document.
