1. We elected not to defer the Appendix; hence, Petitioners' Joint Opening Brief is in final form. We elected not to defer the Appendix because the entire administrative record was relatively short; because we deemed every entry to be relevant and to have independent significance, largely because of the Band's challenge to the standing of the Goshute petitioners; and because, as a consequence, we included the entire administrative record in the Appendix. Inasmuch as the entire administrative record is in the Appendix, there is nothing more any party could request be included in it.
