The purpose of this modification is to (1) provide incremental funding in the amount of \$15,856 to fully fund the subject contract; (2) exercise the option period and extend the subject contract through September 24, 2004 in accordance with the contractor's proposal dated 5/12/03 for the option year. NOTE: This proposal supercedes the previous proposal for the option year and revises the Statement of Work for the option period (Attachment 1); (3) provide incremental funding in the amount of \$83,144 for the option period through November 24, 2003. NOTE: The funding increases from Item Nos. 1 and 3 of this modification totalling \$99,000 will increase the contract obligated amount from \$2,139,000 by \$99,000 to \$2,238,000; (4) increase the contract ceiling amount from \$2,154,856 by \$734,800 to \$2,889,656, and (5) change the project officer as shown below under Section G.1, paragraph (a) of the contract. Accordingly, the following changes are hereby made under the contract:

- Section B.3, "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUNE 1988) ALTERNATE I (JUNE 1991)," paragraphs (a), (c), (d)(to be replaced by (f) below, and (e) are DELETED in their entirety and SUBSTITUTED with the following in lieu thereof:
  - "(a) The total estimated cost to the Government for full performance of this contract is \$2,889,656 of which the sum of \$2,726,091 represents the reimbursable costs, and \$163,565 represents the fixed fee."
  - "(c) The total estimated cost to the Government for full performance of the option year is \$734,800, of which the sum of \$693,208 represents the estimated reimbursable costs, and of which \$41,592 represents the fixed fee."
  - "(e) The amount obligated by the Government with respect to this contract is \$2,238,000 of which the sum of \$2,125,943 represents the reimbursable costs, and of which \$112,057 represents the fixed fee."
  - "(f) It is estimated that the amount currently allotted will cover performance through November 24, 2003."
- 3. Section F.7, "DURATION OF CONTRACT PERIOD (MAR 1987), ALTERNATE 2 (MAR 1987)," the paragraph is hereby revised to read as follows:

"This contract shall commence on September 25, 2000 and will expire on September 24, 2004."
