SUMMARY OF COMMITMENTS, CONCLUSIONS, AND AGREEMENTS

Nevada Test Site STP's (Task Order 004)

1. E.I. will receive formal comments from NRC to aid in preparing the final letter report on the STP's. General NRC comments discussed during the meeting include using a more consistent format on all design STP's, moving many guidance comments from the discussion sections to the site technical position sections, and emphasizing portions of STP's which are anticipated to be controversial.
2. E.I. will review the STP's and insure they are consistent with the final version of the technical rule (10CFR60). Also, E.I. will insure that all technical positions are comprehensively backed-up by justifications in the discussion sections.

Salt Sites (Task Order 005)

1. R. Johnson discussed the status of salt sites under investigation and explained procedures for E.I. to follow in obtaining Department of Energy (DOE) reports and other technical information.
