The NRC staff has performed an acceptance review of the TR. We have found that the material presented is complete enough to begin a review. The staff expects to issue RAIs by March 1, 2004, and complete its review by June 30, 2004, and estimates that the review will require approximately 275 staff hours.

You did not request a fee waiver; therefore, staff hours will be billed accordingly.
