Public Policy Advocates LLC ("PPA") submits its Cover Sheet Application (the "Application") for Allowance and Payment of Interim Compensation and Reimbursement of Expenses for the Period July 1, 2003 through July 31, 2003 (the "Application Period"). - 1. PPA is the Legislative Activities Consultant to the Official Committee of Unsecured Creditors in the Pacific Gas and Electric Company ("Debtor") bankruptcy case. With regard to the copies of this Application served on counsel for the Debtor and the Office of the United States Trustee, attached as Exhibit 1 hereto is an invoice for the Application Period that complies with all Northern District of California Bankruptcy Local Rules and Compensation Guidelines and the Guidelines of the Office of the United States Trustee.
 - 7. PPA has served a copy of this Application (without Exhibits) on the Special

- 8. - 9. The interim compensation sought in this Application is on account and is not final. Upon the conclusion of this case, PPA will seek fees and reimbursement of the expenses incurred for the totality of the services rendered in the case. Any interim fees or reimbursement of expenses approved by this Court and received by PPA will be credited against such final fees and expenses as may be allowed by this Court.
