We have reviewed LLNL Monthly Management Letter No. 11, dated July 7, 1987, that summarizes progress under FIN A-0297 for the month of June 1987. Progress to date appears to be satisfactory. We have the following comments:

As you are aware through our telephone conversation, the BWIP data review has been postponed. However, we have made arrangements to have Dr. Bentley guide us on a field trip to observe structural features of the Yakima fold belt in the BWIP vicinity. We would like Richard Galster to accompany us on this trip, if he is available during the week of August 3, 1987. We anticipate the receipt of a draft report on Purcell's task concerning the potential for erosion, debris dam formation, and/or other geomorphic changes, and the possible resultant entrance of surface water into the proposed shaft and ramp openings of the proposed Yucca Mountain HLW repository, by the end of this month (July 1987). Finally we shall be sending you under a separate cover an initial request for assistance on a task to develop a program that will evaluate the teconics of the Amarillo-Wichita uplift and associated geologic structures. You should have this task within the next week.
