In response to your transmittal letter of July 9, 1986, we have reviewed the referenced document and have the following comments:

- 1. The document contains a notice of restricted distribution. As a matter of public record, we have placed a copy of the report in the Division of Waste Management's Document Control Center and in the NRC's Public Document Room. The report will, upon request, be made available to any interested party. However, no additional copies, beyond those supplied by the Bureau of Standards, are currently anticipated.
- 2. In general, we approve of NBS purchase of the software and hardware described in the subject report. Our approval is subject to the following restrictions:
  - a. Software and hardware purchased by the Bureau of Standards with NRC funding will be returned to the NRC upon completion of the contract.
  - b. The purchase is limited to two (2) IBM-PC systems; one system to be an IBM PC-AT (high-usage site configuration) and one system to be an IBM PC-XT (low-usage site configuration).
  - c. The purchase will include three (3) Bernoulli external disk drives, one for each of the above two IBM-PC systems and one to be delivered to the NRC for installation on an NRC IBM-PC system.
  - d. The purchase shall be limited to disk drives (internal and external) having storage capacities fully supported by IBM DOS 3.1. That is, disk drives shall be limited to 32 megabytes or less.
