SUMMARY:

During this reporting period the Project Descriptive Summary was revised and a copy of the revised PDS is being transmitted to the USBM.

Work Directive 10 was received by the USBM during this reporting period. The USBM is currently reviewing this work directive to determine the most appropriate method of resolution. The USBM has suggested conducting the study in increments with a pilot area to be chosen to see if data needed may be obtainable. Recommendations will be transmitted during the next reporting period. The time frame for completion of the final product to fulfil this work directive may be revised subsequent to receipt of USBM recommendations.

The USBM has been alerted that the Yucca Mountain SCP could arrive as early as September. It is understood, as stated in the revised PDS, that upon receipt of the SCP all work on other work directives shall be discontinued, at no additional cost to the NRC, to allow adequate time for SCP review.

Work continues on Work Directive 11 under Task Order 002 for a map of hydrocarbon and geothermal resources in the Hanford area. No delay is anticipated in the completion date of August 31, 1987.

During this reporting period the USBM was contacted by the State of Idaho in an information request pertaining to work on this Interagency Agreement. The USBM has released a copy of the PDS and SOW to the State of Idaho and will refer any further requests for documentation concerning this request to the NRC.
