The purpose of this modification is to: 1) Increase the amount obligated in the delivery order by \$460,439.00, from 523,801.00 to \$984,240.00, and 2) Consolidate the ceiling amounts of Tasks 1, 2, and 3 of the delivery order into one ceiling amount for the base year of the contract, to allow for greater flexibility in placing orders under the delivery order. Accordingly, the delivery order is hereby modified:

1) Section B, Consideration and Obligation, first and second paragraphs are deleted in their entirety and substituted with the following in lieu thereof:

"The total estimated amount (ceiling) for the base year is \$1,042,144.00."

2) Section B, Consideration and Obligation, fourth paragraph, first sentence, is deleted and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this order is \$984,240.00."

3) Section B, Consideration and Obligation, fifth paragraph, is deleted and substituted with the following in lieu thereof:

"It is estimated that the amount currently allotted will cover performance of the effort through April 30, 2004."

This modification obligates FY2003 funds in the amount of \$460,439.00.
