SUBJECT: Priority list of Data Topics for BWIP Data Review

Terra Therma was requested by Mike Weber (NRC) to compile a list of data topics that we would want included in a BWIP data review which is scheduled for late September. This memo serves as that list. Mike also requested that I call him this week with the list, which I will attempt to do today. The list as presented in this memo is prioritized, number 1 being the highest priority. However, once beyond number 4 or 5, only the relative position on the list has any significance. In other words, the priority is either high, medium, or low.

- 1. Documentation of pressure response of piezometers during inflation of packers.
- 2. Any hydraulic testing conducted on piezometers during well drilling, construction, or development.
- 3. Documentation of process used to filter atmospheric and earth tide effects from water level data.
 - 4. Results of tests of transducers, packers, etc.
 - 5. Details of fluid takes/losses during drilling of piezometers.
 - 6. Interval reports/well completion reports or data.
 - 7. Water quality data from the Westbay installation at DC-14.
 - 8. Documentation of water quality used to fill piezometers.
 - 9. Data on grout permeability testing.
 - 10. Stratigraphic/completion data from DC-23.
 - 11. Any hydraulic testing data performed since the last date provided.
 - 12. Most recent water level data.
