This cover letter transmits to the NRC staff Daniel B. Stephens and Associates' (DBS) semi-annual update of the Conceptaul Model Evaluation Report for the Palo Duro Basin (Subtask 3.4). The report has received a management review by M. Logsdon of Nuclear Waste Consultants. The reports have been completed under DBS's quality assurance procedures in compliance with NWC's project-specific QA Plan.

The DBS update report reviews the team's progress to date in evaluating conceptual model issues. Since the team's approach to evaluating these issues has involved not only the review of specific data (discussed in the Subtask 3.2 reports) but also the analytical evaluations performed under Subtask 3.5, the bulk of the report is a discussion of the technical evaluations completed and in progress. The update report concludes with a set of recommendations, including proposals for two significant areas of new effort: hydrochemical conceptualizations of the Palo Duro Basin and stochastic analysis of uncertainty.
