This cover letter transmits to the NRC staff the Conceptual Model Evaluation Report for BWIP, Subtask 2.4 of Contract No. RS-NMS-85-009. This report has been prepared by the Mssrs. Mike Galloway and Fred Marinelli of Terra Therma and Mssrs. Adrian Brown and Mark Logsdon and Ms. Barbara Basse of Nuclear Waste Consultants, all members of the site team for BWIP. The report has received technical and management reviews by Adrian Brown and Mark Logsdon of Nuclear Waste Consultants.

The report is very extensive, presenting a new framework for considering aspects of conceptual models, reviewing conceptual models proposed to date, identifying areas of technical concern and of technical consensus, and proposing work plans to evaluate information and investigation needs at BWIP. NWC and TTI recognize the nature of the work load that confronts the NRC Staff, particularly during the review period for the Final Environmental Assessments. However, we consider that this report is such a significant departure from other efforts to date to evaluate conceptual models that we consider that it would be extremely worthwhile for the Staff to review this approach in some detail and to present comments to NWC/TTI in a timely fashion in order to facilitate not only updates to this work, but also our work on Subtask 2.5, which is now already underway.


